PRODUCT APPLICATION

Choose all appropriate safety equipment before use. Refer to the Safety Data Sheet for details.

Always test first in several inconspicuous areas to confirm desired results.

1. Spray directly on the area to be cleaned from 5" to 7" (12,5 to 17,5 cm) away.
2. Wipe using a soft clean towel or microfiber cloth.
3. In the case of tough dirt, allow the product to stand for several minutes before wiping. Cleaning may require scrubbing with a white nylon pad.

Close container tightly after each use. Store in original container only. Store between temperatures of 35°F to 90°F (2°C to 32°C). Do not allow to freeze.
