PRODUCT APPLICATION

Choose all appropriate safety equipment before use. Refer to the Safety Data Sheet for details.

Always test first in several inconspicuous areas to confirm desired results.

- 1. Spray directly on the area to be cleaned from 5" to 7" (12,5 to 17,5 cm) away.
- Wipe using a soft clean towel or microfiber cloth.
- 3. In the case of tough dirt, allow the product to stand for several minutes before wiping. Cleaning may require scrubbing with a white nylon pad.

Close container tightly after each use. Store in original container only. Store between temperatures of 35°F to 90°F (2°C to 32°C). Do not allow to freeze.
